Job Purpose: To lead a team in carrying out the duties of development control including providing

statutory planning consultations, technical vetting, inspections and adoption of development related highway works under Section 38, 184 & 278 of the Highways

Act 1980.

Main Duties and Responsibilities:

- 1. Provide a comprehensive response, as a representative of the Local Highway Authority, to the Planning Service in response to statutory consultations in respect of planning applications and Preplanning enquiries for new development. This will include evaluation of Transport Assessments and/or Travel Plans, negotiating developer contributions and assessing highway infrastructure requirements under a S106 Agreement. A proactive approach will be essential in finding solutions to assist with the Council's Growth Agenda. (10%)
- 2. Take the lead role for major developments whilst mentoring and supervising others on preapplication enquiries and planning application consultations. Allocate and monitor performance of others in both quantity and quality for all consultations. (5%)
- 3. Undertake the detailed technical assessment of development related highway works proposed for agreements under Section 38 and Section 278 of the Highways Act 1980 with a view to offering technical approval in a timely manner. (10%)
- 4. To be the lead senior officer and advise colleagues on matters relating to the technical vetting, approval, inspection, adoption and maintenance of drainage and SuDs elements of developer led highway schemes submitted under S38/278 of the Highways Act 1980.(5%)
- 5. To work as part of the team ensuring that Peterborough meets its requirements under the Flood and Water Management Act 2010 and the Highways Act 1980.(5%)
- 6. To work closely alongside other officers and teams within Planning, Transport and Engineering to ensure that the SuDS process works smoothly right through from approval of drainage applications, to the adoption and ongoing maintenance of the systems by PCC. (4%)
- 7. To lead and co-ordinate the vetting, inspection and adoption of development related highway works under Section 38 and Section 278 of the Highways Act 1980. This includes serving notice and undertaking enforcement action where works have not been carried out in line with formal agreements. (10%)
- 8. To mentor, train, supervise and monitor all colleagues with respect to carrying out technical vetting under Section 38 and Section 278 of the Highways Act 1980 to ensure that a comprehensive and timely response is provided. Constant monitoring of technical vetting will need to be carried out to ensure an excellent quality and fully detailed response is always provided. (5%)
- 9. Inspect highway works in relation to Section 184/38/278 of the Highways Act 1980. Ensure formal adoption of new highway works or existing highway works. (5%)
- 10. Provide advice on implementation, construction and adoption of new, and improvement of existing highway works relating to development including inspection and approval. Where necessary give consideration and approval to temporary traffic management proposals. (5%)
- 11. Assist the drainage team with the review of developer led sustainable drainage systems. (2%)
- 12. Lead, or assign appropriate staff to lead, on delivering the transportation elements of major development sites in Peterborough arising from the Growth Agenda, e.g. committed developments including North Westgate, Paston Reserve, Stanground South, Hampton Leys, Hempsted, Great Haddon, Fletton Quays and proposed developments including Station Quarter and sites identified through the Integrated Growth Strategy (IGS). (2%)
- 13. Be expert on and lead on the implementation of new techniques, technologies and urban design thinking thereby maintaining current and appropriate knowledge of legislation & guidance applicable to the team's services to ensure it is prepared to meet the challenge of the Growth Agenda, e.g. be conversant with National and Local policies and guidance including; DfT Manual for Streets, Design Manual for Roads and Bridges and Transport Assessment Guidelines, NPPF, PCC Integrated Growth Strategy, Local Transport Plan, Structure Plan, Local Plan and any other subsequent/superseding publications. (2%)

- 14. As a representative of the Local Highway Authority, when consulted, provide advice in respect of transport aspects of proposed policies, e.g. LDF and daughter documents, residential design guidance, etc. (2%)
- 15. Oversee and manage the adoption of new highway infrastructure under Section 38, 184, 278 of the Highways Act 1980, from initial technical vetting through to adoption. (2%)
- 16. Oversee the authorisation of temporary directional signage associated with new development. (2%)
- 17. Assist the team manager with monitoring and management of the teams budgets. (2%)
- 18. Represent the Local Highway Authority at all Planning & Environmental Protection Committees unless cover is provided by one of the Senior Engineers. (1%)
- 19. Commission relevant legal agreements in respect of new highway infrastructure works. (1%)
- 20. Work with the Legal Team to continually improve the wording of legal agreements and the working processes between the two teams. (1%)
- 21. Lead on the production of highway development control guidance, procedures and advice notes to be published on the Council's Website and thereafter continually update as and when necessary. (2%)
- 22. Prepare statements of evidence in respect of transportation aspects of planning appeals as well as advising and mentoring of others within the team carrying out this task. (3%)
- 23. Give evidence at planning appeal public inquiries and informal hearings as an expert witness on behalf of the Local Highway Authority. (2%)
- 24. Be conversant with current planning guidance (NPPF, etc.), highway guidance (for instance Manual for Streets, DMRB, etc.), Highways Act 1980, Structure Plan, Local Plan and Local Transport Plan. (1%)
- 25. Represent the Council on transportation matters as may be required at meetings with the public, developers, agents, Councillors, Parish Councils, other local organisations and external bodies. (1%)
- 26. Provide timely responses to all statutory and discretionary consultations received. (1%)
- 27. Be the lead contact for any initial enquiries, complaints or queries relating to highway development control. (1%)
- 28. Deal promptly and efficiently with enquiries and correspondence, and managing this activity across those under your line management within the team. (1%)
- 29. Take a lead role and identify opportunities in the development of IT applications for improved service delivery. (1%)
- 30. Provide timely expert advice to colleagues, developers and the public in respect of highways development control as and when required. (1%)
- 31. Be familiar with Council's procedures, in particular Standing Orders relating to contracts. (1%)
- 32. Provide support, including on the job training to those posts under your line management, whether permanent, temporary, shared or seconded. (1%)
- 33. To carry out all responsibilities with regard to the Council's Equalities Policy and Procedures and Customer Care Policy. (1%)
- 34. To comply with all Health & Safety at work requirements as laid down by the employer. (1%)
